

Using Explosive Substance or Corrosive Fluid With Intent

s.47 (NSW) Crimes Act

s 47 Do any of the following with intent to burn maim disfigure disable, or do grievous bodily harm to, any person
 cause any gunpowder or other explosive substance to explode,
 send, or deliver to, or cause to be taken, or received by, any person, any explosive substance, or other dangerous or noxious thing,
 put or lay at any place, or cast or throw at, or upon, or otherwise apply to, any person, any corrosive fluid or any destructive or explosive substance (including petrol)

Maximum Penalty: 25 years

4.	Nydegger (44) [2024] NSWCCA 232	Throw explosive substance with intent to burn	PG (25%)	6y 9m NPP 4y 4m	AD	Drugs, driving.	Threw petrol at male friend – victim suffered burns to 11% of total body surface, including hands, face, neck, left thigh and chest - believed victim said something of a personally threatening nature – delusional belief, psychotic illness (schizophrenia) - accepts victim did not in fact say anything – spontaneous offence. Schizophrenia substantial contributing factor - substance use disorder – mental illness – prior good character.
