

## Aggravated Sexual Intercourse Without Consent in Company

Victim Aged 16 Years or Older

s.61JA (NSW) Crimes Act

s 61JA(1) (a) sexual intercourse with another person without consent of that person knowing that person does not consent, and

(b) in company of another person or persons, and

(c) (i) intentionally or recklessly inflicts actual bodily harm on victim or any other person who is present or nearby, or

(ii) threatens to inflict actual bodily harm on victim or any other person who is present or nearby by means of an offensive weapon or instrument, or

(iii) deprives victim of liberty for a period before or after commission of offence

**Maximum Penalty:** Life

**Standard non-parole period:** 15 years (for offences committed on or after 1.2.2003)

**Commenced:** 1.10.2001
