

## Aggravated Unauthorised Possession of More Than Three Unregistered Firearms

s.51D(2) (NSW) Firearms Act

s 51D(2) possession of more than 3 firearms, any one of which is a pistol or a prohibited firearm where:

- (a) the firearms are not registered, and
- (b) the person is not authorised by a licence or permit to possess the firearms.

**Maximum penalty:** 20 years

**Standard non-parole period:** 10 years (conviction entered or guilty plea taken on or after 1.1.2008)
