- (b) in company of another person or persons, and
- (c) (i) intentionally or recklessly inflicts actual bodily harm on victim or any other person who is present or nearby, or
 - (ii) threatens to inflict actual bodily harm on victim or any other person who is present or nearby by means of an offensive weapon or instrument, or
 - (iii) deprives victim of liberty for a period before or after commission of offence

Maximum Penalty: Life

Standard non-parole period: 15 years (for offences committed on or after 1.2.2003)
